PART- I (TECHNICAL BID)

1. NOTICE INVITING TENDER - SALE/AUCTION

Notice for Tender - Sale / Auction of Used Diesel Generator Set (40KVA – 1 No.)

Kerala Cricket Association invites Tender - Sale / Auction for Used Diesel Generator Set (40KVA -1 No.)

1. Interested parties are requested to submit the Bids in sealed envelope for the sale/auction as per details in this tender document.
 - Sealed Bids in TWO separate sealed Envelopes indicating clearly '**Envelope - No.1 - Technical bid**' and '**Envelope No.2 – Price bid**', shall be addressed to

- Envelops should also be super scribed-
“Tender – Sale/Auction of Used DG Sets”.
- **Last date for the submission of tender is 19.09.2024, 4.00 pm.**
 - **Technical bid and price bid will be opened on 19.09.2024, 5.00 pm at KCA office, Thiruvananthapuram.**
 - **All the Bid documents are to be send to this office by Registered / Speed post/Courier/ Manual submission at the tender box provided at KCA Head office at Trivandrum.**
 - **Late tenders will not be accepted.**
2. Tender document can be downloaded from our website www.keralacricketaassociation.com The tender document will be available on the website, till the last date of submission.
 3. Reasons for sale/auction: Diesel Generator sets (40 KVA – 1 Number) were used for power back up for KCA head office at Trivandrum. Due to the increased power requirement for head office the DG was upgraded recently. Hence the used DG sets are being auctioned.
 4. Estimate report from 3rd party consultant is attached as addendum 01 for reference.

5. The two envelopes must carry the following:

Envelope no. 1:

- a. "Technical bid" of tender with every page signed and stamped.
- b. An initial part amount of **Rs 10,000/- (Rupees Ten Thousand Only) towards Earnest Money Deposit (EMD)** by way of Demand Draft (DD)/Bank Guarantee from Nationalized/Scheduled Bank and **Bid Document Fee Rs.2,950/-** including GST should be remitted to the **A/C No. 13800100303237 IFSC: FDRL0001380 Bank: Federal Bank**

Ltd., Palarivattom, Ernakulam Branch and the UTR receipt should be submitted along the Bid documents. Only Internet Banking is allowed as mode of payment for Bid document fee. The Tender without EMD shall be rejected out rightly. No interest shall be paid on the EMD thus collected. EMD of the successful bidder shall be refunded after the successful completion of the work, whereas EMD of the unsuccessful bidders will be refunded upon the issuance of work order to and acceptance of the same by the successful bidder.

Envelope No.2:

- a. Price Bid shall be addressed to The Secretary, Kerala Cricket Association, K.C A Complex, T.C- 28/152, Sasthamkovil Road, Thycaud, Thiruvananthapuram 695014
- b. Envelope No.2 shall not contain any condition whatsoever and any conditional price bid shall be rejected.

6. If the last date of receipt or opening of the tenders happens to be a holiday for KCA, then the receipt and opening of the tenders shall be shifted to next working day without change of time and venue.

7. Before filling up the tenders, the bidders may note the following:

- a. The bids shall remain valid and open for acceptance as per the dates mentioned in the tender notice. If the tenderer withdraws his tender before the expiry of the said period or makes any modifications in terms and conditions of the tender which are not acceptable to the KCA, then the KCA without prejudice to any other right or remedy will be at liberty to forfeit the earnest money.
- b. The tenderer should quote the rates in figures as well as in the words. The rate for each item should be worked out and the requisite total amount shall be calculated accordingly. Rates quoted by the bidder in item rate tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates, figures and words. However, if a discrepancy is found in the rates in words and figures, then the rates quoted in words shall be taken as correct.

- c. **The tenderers must include in their tender prices quoted for GST transportation charges, loading and unloading charges, labour charges and any local charges etc. if applicable. No extra claim on this account will in any case be entertained.**
- d. The tender document must be filled in English. If any of the documents are missing or un-signed in price bid, the tender shall be considered invalid. In case of technical bid, the details of incomplete or missing documents will be intimated to the tenderer and the tenderer has to submit all those documents within 01 day after communicating the same, otherwise the tender will be rejected.
- e. KCA reserves the right to accept or reject any /all tender/s in part or whole of any firm / firms without assigning any reasons for doing so.
- f. All taxes including GST or any other payable/ prevailing tax on material or on finished works etc or insurance cost, transportation etc, in respect of this contract shall be payable by tenderer and the KCA will not entertain any claim whatsoever in this respect over the quoted price.
- g. ***Before quoting, the tenderer shall inspect the site, to fully acquaint himself about the condition in regard to accessibility of the site, working condition of site, locality including installations of tools and plants (T&P) and local authority regulations / restrictions if any, conditions affecting accommodations and movement of personnel etc. required for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by the KCA in any circumstances.***
