4	The OEM / contractor should have completed at least Five work with LED Sports lighting of cricket stadium complying to International illumination lux level with Telecasting provision under authority of State / Central Govt/ Private reputed customer and having a magnitude of minimum > 6 Crores (including GST without O&M cost) in India minimum 5 projects in cricket field lighting arena in India.	The OEM / contractor should have completed at least Five work with LED Sports lighting of cricket stadium complying to International illumination lux level with Telecasting provision under authority of State / Central Govt/ Private reputed customer and having a magnitude of minimum > 6 Crores (including GST without O&M cost) in India minimum 5 projects in cricket field lighting arena in India or a. Three similar completed stadium works costing not less than the amount equal to 40% of the estimated cost or b. Two similar completed stadium works costing not less than the amount equal to 50% of the estimated cost or c. One similar completed stadium work costing not less than the amount equal to 80% of the estimated cost as per norms.

8	OEM should have provided LED lighting system and DMX control systems to cricket stadiums and at least 50 international matches should have played and telecasted collectively in those stadiums in India.	OEM should have provided LED lighting system and DMX control systems to cricket stadiums at least 50 International matches, IPL, Telecasted Board (BCCI) matches or Telecasted State League matches should have played and telecasted collectively in those stadiums in India. Supporting documents shall be attached for the same priority wise.
