

## Tender Notice for LED Floodlighting System with DMX Controls for Three Cricket Stadiums of Kerala Cricket Association

Sealed tenders are invited for the proposed LED Floodlighting system with DMX control for three stadium of Kerala Cricket Association viz. KCA Cricket Stadium at Mangalapuram Thiruvananthapuram, KCA-SD College Ground at Alappuzha & Krishnagiri Stadium at Wayanad.

**Kerala Cricket Association** ( KCA) , invites proposals for Survey, Design, Supply, Installation, Aiming, Testing, Commissioning of Sports lighting system with five years product warranty for three first class grounds in Kerala.

The firms who meet the eligibility criteria shall bid for the work and shall collect the tender document from the office of Kerala Cricket Association, KCA complex, Sasthamkovli road, Thycaud, Thiruvananthapuram, Kerala - 695014 on payment of Rs. 25,000/- (non-refundable) to the bank account of KCA on any working day between 11:00 a.m. to 6:00 p.m. from 11/12/2024 to 15/12/2024 (both days inclusive).

The bidder shall pay **Earnest money deposit of Rs. 34,00,000/-** (Thirty Four Lakhs only) in the form of Demand draft or Cheque in favour of "**Kerala Cricket Association**" from a Nationalised bank with their proposals at the time of submission of tender document.

The OEM / Contractor must fulfil the following eligibility criteria:

- 1. OEM and contractor should be operating in India for at least 10 years and should have dedicated team for after sales and service support. If contractor is not OEM, then authorization letter from OEM is required. Bidder should mandatorily have valid Kerala PWD Electrical Class A License. Bids from Joint Ventures are not Allowed. (AMENDED)
- 2. The average annual turnover in India for last three years of OEM should be not less than Rs. 400 Crores in B2B Professional lighting business. The same shall be established with declared and publicly available documents like; Annual reports etc. to qualify for participating in this Tender. (AMENDED)
- 3. The OEM / contractor should have executed and commissioned similar work of international level sports cricket stadium flood lighting with LED and DMX control in India.
- 4. The OEM / contractor should have completed at least Five work with LED Sports lighting of cricket stadium complying to International illumination lux level with Telecasting provision under authority of State / Central Govt/ Private reputed customer and having a magnitude of minimum > 6 Crores (including GST without O&M cost) in India minimum 5 projects in cricket field lighting arena in India. (AMENDED)
- 5. Lighting firm (OEM) should have own or dedicated vendor manufacturing facility for High Wattage LED fixtures (more than 1500W) in India.
- 6. The Lighting firm (OEM)/ Contractor is to submit the bid directly or provide an authorization letter to their Vendor (OEM) with Tender, but the lighting firm shall be responsible for Survey, all design support, installation, aiming, testing and commissioning. The successful bidder should do Operation and Maintenance (minimum five years) of the sports lighting systems and ensure its performance. The Lighting Firm should also provide a warranty against manufacturing defects for a period of 5 years.
- 7. OEM / Contractor should have in house and dedicated expert lighting design team for doing Lighting design and also should have inhouse and dedicated technical engineering & services team for aiming, field measurements, commissioning & programming of the system and services. Necessary Declaration Documents as proof for the above will have to be submitted by OEM.
- 8. OEM should have provided LED lighting system and DMX control systems to cricket stadiums and at least 50 international matches should have played and telecasted collectively in those stadiums in India. (AMENDED)
- 9. The OEM should have NABL accredited Test Laboratory in India with capability to check all photometric parameters.

Kerala Cricket Association reserve the right to accept / reject any or all proposals including tender without assigning any reason thereof.
