- 1. In case the Tender submitted by the Bounden is accepted by the KCA and the Contract for "Fabrication of Compound Fencing Works at KCA Twin Cricket Ground, Thodupuzha." is awarded to the Bounden, the Bounden shall within 7 days of acceptance of his Tender, execute an Agreement with the KCA incorporating all the terms and conditions under which the KCA accepts his Tender.

- 3. All sums found due to the KCA, under or by virtue of this agreement shall be recoverable from the Bounden and his properties, movable and immovable, under the provisions of the PREVAILING LAW for the time being in force and also in such other manner as the VCA may doen fit
